Herrs called Zoning Administrator Dan Davis, and he sent them a copy of the ordinance. Davis's interpretation of the ordinance from 1969 was that it meant a permanent structure that couldn't be moved. Mr. Herrs stated that there are already people living in the area in campers and also at Bartlett Shores, with all campers. Davis said that Bartlett Shores went through the platting process, allowing them to have RVs. Theresa said they are trying to do things the correct way. They have gone through the proper channels with permits and a survey. Auditor Owen asked if any kind of exception to the ordinance could be given. Davis said the Board of Adjustment could consider granting a variance and work out the details. Sheldon said he didn't see a problem granting a variance. Davis said it would take some time to publish and go to the board for a hearing. Blackburn stated, like Sheldon, he wouldn't have a problem with it. Shearer asked why it got stopped in the first place if there was no ordinance prohibiting a septic on land with no house. Davis explained said they had people changing jobs and no one told them to speak to Davis. The board told them they appreciated them doing things the right way. Davis will give them the application for a variance and get the process started as quickly as he can.

Treasurer Alise Snyder met with the board regarding stamped warrant interest.
